#### 2014 Mission Viejo Chili Cook-Off Rules

- 1. Submit application and fee no later than Tuesday, March 4 at 5:00 pm.
- 2. The 2014 Mission Viejo Chili Cook-off accepts meat and vegetable chili.
- 3. The entry fee is \$25 per chili contestant. One chili type per contestant.
- 4. The chili can be made 24 hours prior to the event and brought ready to serve.
- 5. Contestants must arrive no later than 10:30 am for set up of the event. Set-up begins at 9:30 am.
- 6. A list of ingredients in the chili, without the quantities, will need to be provided for the cook-off administrators for allergy purposes. Ex: "Tomato paste" is fine; don't need to specify "Hunt's tomato paste."
- 7. Contestants are expected to provide a minimum of 8 quarts of chili pot to the contest.
- 8. Small cups/bowls to serve the chili in will be provided for public consumption.
- 9. Contestants will be responsible for the maintenance of the chili's appropriate temperature, to facilitate a chili temperature that is safe to consume. Contestants will need to supply your own crock pot or devices to maintain the chili's heat.
- 10. A power source with cords and outlets will be available on a first come, first serve basis.
- 11. One 6' tables and two chairs will be provided.
- 12. Once the contestants arrive they will be assigned to a numbered booth. The public and judges will use this number to vote upon which chili they like the best.
- 13. There will be an award given based on the decision of the 5 selected judges, including the decision of the public.
- 14. Each contestant is responsible for watching over their given area and serving their chili to the judges and the public.
- 15. Contestants will be expected to clean up their given area once the contest is over.
- 16. There will be no eating, smoking, or drinking will be allowed while serving the chili.
- 17. There will be no bare hand contact with food.
- 18. There will be no unauthorized persons will be allowed in the food prep area.

#### Judging Guidelines:

Criteria for chili will be based on overall taste, appearance, and originality/authenticity.
