

# ATTENTION PET OWNERS!



Mission Viejo Animal Services provides service to the Cities of Mission Viejo, Laguna Niguel and Aliso Viejo. One of the biggest problems officers face is an alarming number of dogs and cats picked up without a license or I.D. tags.

Mission Viejo Code 10.01.221 (a) states “every person owning or having custody of any dog four months of age or older shall procure for the dog a city dog license. Such license shall be procured within 15 days after the date on which it becomes due.”

Cat licenses are voluntary and are available at \$6.00 per cat. Pet owners must show proof of Rabies Vaccination to obtain a license.

**If your pet is lost, Animal Services wants to return it safely to you as soon as possible. Pets can't talk or carry a wallet. A license gives your pet a lifeline back to you!**
