The qualifications for appointment for each of the positions listed above are as follows: (1) registered voter and (2) resident of the City of Mission Viejo. Two members of the Community Services Commission are senior citizens and must also be over the age of 55. Additionally, applicants for the Investment Advisory Commission should have one or more of the following qualifications: (1) banker, vice president level or above; (2) investment banker, vice president level or above; (3) financial planner; (4) corporate chief financial officer or treasurer; (5) registered investment adviser; or other qualified individual.
