SENIOR-DISABLED TRANSPORTATION RESOURCES

PRIVATE PROVIDERS:

1. Non-Emergency Medical Transportation

(c/o Age Well Senior Services, Inc.)

- Must be 60 years of age or older and reside within the South Orange County.
- Application required.
- Cost per one-way ride is \$2.00 (exact change required); care attendants ride for free.
- Non-emergency medical appointments include: therapy, dentistry, prescription pick-ups, testing, x-rays, dialysis, hearing tests, etc.
- Service within greater South Orange County including satellite destinations of Kaiser Anaheim, (Lakeview); Long Beach Veterans Hospital.
- Trip destinations outside of the designated service area are limited to **15 miles** from customer residence to facility.
- Program hours: Monday Friday 7:00 a.m. 6:00 p.m.; wheelchair accessible; service is not be available on major holidays.

2. Saddleback Memorial Medical Center Transportation

- **Free** transportation for cardiac rehab, oncology and radiation patients, and physical therapy patients. •
- Requires doctor's authorization.
- Arrangements are made "at point of service" through doctor's office

3. <u>American Cancer Society ("Road to Recovery")</u>

- Volunteer transportation services for cancer treatments within Orange County only.
- Ambulatory patients only; no wheelchairs walkers permitted.
- Caregiver is required if assistance is needed.
- Must call 3 business days prior to appointment.

PUBLIC TRANSPORTATION SERVICES/RESOURCES:

1. OCTA Big Bus/ Fixed Bus Route System (subject to change)

- Seniors /Disabled .75 cents per boarding; \$1.50 for day pass, \$8.55 for a 7-day pass, \$22.25 for a • 30-day pass; other service discounts available

2. OCTA / ACCESS Service (rates subject to change)

ACCESS reservations – 1-877-628-2232

- Shared ride paratransit service for individuals who are **physically and/or cognitively disabled** and **unable to use OCTA's fixed bus route** system.
- Qualified rider must also live within a ³/₄-mile of a OCTA fixed bus route to receive this service; call 1-714-560-5956 #3 to confirm ³/₄ proxity to a local bus route
- Applicants complete an <u>OCTA ADA Paratransit Application</u> and certify eligibility through an in-person functional assessment at the OCTA assessment center. (<u>Note</u>: Application and assessment appointment can be made over the phone -1-714-560-5956.)
- ACCESS approval process is approximately 21 days from assessment date
- ACCESS service is available seven days a week in the same areas and during the same hours as the fixed-bus route service; service is available countywide.
- ACCESS trips are scheduled within 60 minutes of requested time; customers are picked up within a quoted "pick-up" window; ride times generally range from 60- 90 minutes
- Must request a ride at least 1 day in advance and up to 3 days in advance
- \$3.60 per one way trip, up to 5 miles (curb to curb)
- Wheelchair accessible; call for equipment specifications
