Notice is hereby given of the availability of the revised 6th Cycle (2021-2029) City of Mission Viejo General Plan Housing Element Mission Viejo Housing.

REVISED GENERAL PLAN HOUSING ELEMENT UPDATE
The Housing Element includes analysis of the community's housing needs, opportunities and constraints, as well as policies and programs to facilitate the construction, rehabilitation, and preservation of housing for all economic segments of the community. The City is required by State law to prepare an updated Housing Element for the 6th Cycle planning period (2021-2029). Staff has revised the currently adopted Housing Element in response to comments received from the public and the State Department of Housing and Community Development ("HCD"). A public hearing will be held by the Planning and Transportation Commission to consider the revised Housing Element Update and forward a recommendation to the City Council. A second public hearing will be held by the City Council to review the recommendation made by the Planning and Transportation Commission and consider adoption of the revised 2021-2029 Housing Element, in accordance with state housing law.

CEQA DETERMINATION:
An Addendum to the Mission Viejo General Plan Program Environmental Impact Report (State Clearinghouse #2012031065) ("Mission Viejo General Plan Program EIR") was prepared for the project in accordance with California Environmental Quality Act ("CEQA") Guidelines. The Addendum examined potential impacts generated by the proposed project and determined the 6th Cycle Housing Element produces no greater impact than those described Mission Viejo General Plan Program EIR. On October 12, 2021, the City Council adopted the Addendum to the certified Mission Viejo General Plan Program EIR.
