ABOUT THE TEEN BLOG TEAM	
The Teen Blog Team's purpose is to create content for the Mission Viejo Library Teen Voice blog, a resource for the community that promotes literature for teens. Its content includes book reviews and other literary information. Team members earn one hour of volunteer service credit for contributing one blog post (200-500 words) and two comments on other Team members' posts. Teen Blog Team members will be credited with a byline that includes their first name, last name initial, and age. No identifying information (telephone numbers, address, etc.) will be made public via the blog.	
Time Requirements: The Teen Blog Team does not meet on a regular basis. Participation is mostly virtual, via email. There are occasional, optional face-to-face opportunities to earn service credit. Team members agree to commit to a minimum of three months' participation. The minimum monthly requirement for continued participation in the Teen Blog Team is one blog post per month and two blog comments . If a participant misses three deadlines without notifying the Teen Services Librarian, they can no longer participate in the project.
